I would like to discuss the topic of bad emails kicking out of our LISTSERV and eventually dropping off the membership rolls. We are receiving an increasing number of emails with the extension sc.rr.com being rejected (rr is Road Runner, the mail server for Spectrum).

Question: Can we send individual emails to members with this extension type to request a change to a different email address so we can update the mailing lists?

(Brian) The list server's tech team response:

“1. Each bounce-back notification includes an attachment that tells you EXACTLY why the message was returned. For instance, crattycrofton@sc.rr.com was bounced because: 550 5.1.0 sender rejected. Please see <https://www.spectrum.net/support/internet/understanding-email-error-codes> for more information. AUP#In-1310

If you go to that link and look up 1310 you'll see:
1300 - 1340

Spectrum limits the number of concurrent connections from a sender, as well as the total number of connections allowed. Limits vary based on the reputation of the IP address. Reduce your number of connections and try again later.

Basically, it's saying it limits how many server connections and messages per connection they'll allow to be received during a specified period. I can't control that since we have hundreds of lists, and even if I could they don't provide any information on what those limits are so I have no idea how to control the flow to sc.rr.com addresses. Normally, this would mean the messages would sit in the queue waiting until they will accept delivery, however, they appear to have their system to bounce those messages. Again, there's nothing I can do about that as those sorts of settings and decisions are out of my control.

2. As I've noted several times, the end users can resolve this issue by configuring their antispam settings properly and whitelisting the islc.net domain which should, AFAIK, bypass those sorts of limits.

3. I don't work for Spectrum and have no inside knowledge about what they may or may not be doing with those old email systems. I found articles doing a Google search that said they are discontinuing service and some that said they weren't. However, it's been my experience with big companies that

they don't like having multiple email domains (the old Davidson Cable davtv.com addresses for instance) or maintaining legacy email systems.

The Winter/Spring Semester ended on Tuesday, May 21st. In May, we offered eight classes. Total attendance for May was 74. The income was \$350 as four members attended a free class at the beginning of the month. In April, we offered 17 classes. In March, we offered 12 classes. In February, we offered 17 classes, and in January, we offered nine courses for 63 class offerings. The total income for this semester was \$3755. Thank you to all of our education volunteers behind the scenes, Class assistants, and Instructors. Summer lectures begin after July 4th.

I think we are reaping the benefits of the upgrades we have been doing the last few years. Issues this last month have been minor.

We will continue to migrate the facility PCs from Windows 10 to Windows 11. Microsoft support of Windows 10 ends October 1925.

We did briefly discuss the Microsoft Copilot+ PCs and their Recall feature (this feature remembers everywhere you've been and done). We may purchase one later in the year, but there are doubts that we can make use of it privately. Deep Freeze can't deal with the cloud, my hopes are not high for it dealing with Recall. Time will tell.

The opening balance for the month of May was \$29,525. We received income in the amount of \$3,585 attributable to membership dues collected of \$1,645 and education classes of \$1,790. We also had open room sales of \$150. Expenses for the period were minimal. \$233 in non-capital Hardware \$167 for printing supplies and \$61 for software subscriptions. We're ending cash available \$32,648.

I would like to introduce a new report that is an income expense comparison year-to-date with the prior year. Because we do not have monthly budgets there is nothing to compare our data to until we get to the final month when we can compare it to the budget. I think this year-to-date comparison with the prior year will give you a little bit more insight as to how we are doing currently. Secretary’s Note: In this report, Tom is changing the column heading **Variance** to **Remaining Budget**.
