#### Standing Committee Reports

#### Education: Mark Davis

Our Free Summer Class/Lecture Series was very successful! In July we offered 12 Classes/Lectures. In August we ended the month having offered nine Classes/Lectures. We served 174 members in July and 143 members in August for a total of 317 members attending classes this summer. Our average class size was 15 members.

Our Fall Semester begins on Tuesday, Oct. 1st. It will end by Friday, December 12th. At present, we have 16 classes offered during October. More classes may be added in the next week or two.

Faronics has released a major version update to Deep Freeze product that we are using to not retain information on the computers in the club between users. We are in the process of rolling that out to the systems.

The monitor's system had started shutting down randomly. The power supply was shutting down, and has been replaced.

On September 1, 2024, all Computer Club members received an email notifying them that membership renewals for 2025 were open. The email also extended the memberships of those who joined or renewed in August until December 31, 2025.

To ensure timely renewals, members will receive reminders at the beginning of October, November, and December. Additionally, they're encouraged to renew at the Club Fair on October 5th.

As of today, 841 individuals have renewed their memberships for 2025, bringing

the total membership to 3,403.

We want to thank the club members that have volunteered to complete surveys used to refine the development of the new website.

### **Treasurer's Report**

### Treasurer's Report Details as of September 13,2024

Our Checking Balance on September 13th was \$29,460.We have two certificates of deposit that amount to \$31,000, resulting in an adjusted cash balance of \$60,460.

Our opening cash balance for the year was \$35,193. Income for the year has been \$20,168, of which \$10,000 we purchased a certificate of deposit, resulting in

total funds available of \$45,361.00. For the period, we had General and Administrative expenses of \$4,426, Facility expenses of \$10,957 and SIG expenses of \$517, all totalling \$15,901. The resulting year-to-date register balance is \$29,460.
