Treasurer's Report Details as of YTD February 17,2025

2025 Treasurer's Report

We opened the year with \$28,878. In the period January 1st through February 17th we had income of \$12,894. Membership dues received was \$7,125; open room cash sales were \$409; education class fees were \$635; and holiday party fees received during the period were \$4,725. Expenses for that same period were \$1426 and mainly attributable to facility expenses of \$1,226. Our closing balance for this period was \$40,346. In addition, we have two CDs amounting to \$31,654. These are 5-month securities with due dates of 3/28/25 and 4/15/25.

Speaker Introduction:

Mark Davis began with an overview of the new Computer Club website. Some of the work was hired out, which cost \$4500, but mostly the work was completed by a committee. The committee consisted of Bud Brooks, Sue Dobs, Carol Malcom, Bonnie Potts, Brian Osgood, and Jeff Glazer.

Bud Brooks gave a history of the current site. We will still use WordPressBlogger to maintain the content. We will continue to use GoDaddy as a server, costing \$800 - \$900 per year. We will have more than one webmaster so the responsibility for maintenance can be shared. The new site will launch March 1st or March 15th.

Brian Osgood explained how we will post new information via Blogs. Blog ownership will belong to administrators and authors. Appearance and navigation will be consistent. A logo will appear at the top of each blog. A training document and one-on-one training will be provided to each blog administrator and author.

Mark Davis showed the main navigation and access to the calendars for classes and walk-in Help sessions. The Education blog will have links to recorded classes. Click Help to see the walk-in help sessions and who will be at the club at what time.
